# NPC calls for OP Commissioner at Human Rights webinar

Leading advocates of older people's rights called for an inquiry into pandemic care failures and an end to endemic ageism at the NPC's second webinar on 3rd December. Speakers told of multiple, long-term failures in social care policy – exacerbated by underlying ageist attitudes – which led to tragedy during the pandemic. And there were warnings that the lessons from the first lockdown have not been learned. Chair, NPC General Secretary Jan Shortt said: "This was an important discussion on ageism in the UK, and its impact on human rights and hate crime against older people. # Public Transport may not recover

## <u>unless action taken</u>

The NPC wants government action to avert huge cuts in public transport services and concessionary fares in the wake of the Covid-19 pandemic.

The National Council has backed a Transport Working Party Report which expressed fears that when things return to normality after the pandemic, public transport will have been decimated. This will lead to train services and staff cuts, impacting heavily on older people who most rely on bus and train services

NPC Vice President and Transport Expert Peter Rayner said: "Public transport is vital for the physical economic and mental well-being of older people, many of whom for whatever reason do not drive and cannot afford taxis. It is a proven, researched fact that older people also value the presence of staff when travelling.

"It is my view that if you run a train with no Guard to an unstaffed station, it is then a 'Provision, Criterion, or Practice' that discriminates against disabled and older people who are persons of reduced mobility as defined

#### by the Equality Act 2010" Furthermore research has many times established that

older people if they can have inclusion in society, contribute to that society as well as benefitting themselves.

# <u>Pensions & Incomes WP meets</u> <u>BBC Policy Director</u>

The NPC Pensions and Income Working Party held a 'constructive' meeting with BBC Director, Policy, Clare Sumner.

The online discussion on 23rd November followed an earlier meeting between NPC General Secretary Jan Shortt, Ms Sumner, and BBC Director General Tim Davie. Both BBC leaders want to better understand the role of universal entitlements such as the free TV licence for over 75s. Further talks with BBC Diversity & Inclusion Officers & the NPC are planned for 2021, to discuss why BBC diversity and inclusion policy documents must reference older people as well as other groups.

At the PIWP meeting, presentations were made by members on:

- NPC policy on a universal state pension set at 70% of the National Living Wage, uprated by the triple lock; and inequalities between the two pension schemes (pre and post 2016).
- The gender pension gap; causes of pensioner poverty; intergenerational fairness.
- The contribution still being made by older people to the economy and their communities, such as supporting families
- The negative language around older people, which makes it easier to change policies, as society believes the myths about wealthy pensioners/house ownership etc.

Another meeting will be arranged in January 2021 after the PIWP has discussed the triple lock and the impact of COVID on older people. A full report on the talks will follow soon.
